- To develop a robust multi-agency dataset and to agree dates for quarterly reporting
- To use data to challenge partners and to quickly identify areas for improvement & scrutiny
- To agree QA processes that will evidence impact of the WSCP group activity on improved practice and outcomes, maintaining a strong grip on timescales and expectations, including oversight of LCSPR Action Plans.
- Reporting into Executive quarterly and by exception on the progress of all working groups
- To ensure all multi-agency policies and procedures are reviewed and updated in line with national guidance and legislation
